**(1) Confirmation of the last minutes (last meeting on 3-12-2015)**

**(2) To discuss about Implementation of 7<sup>th</sup> Central Pay Commission Report**

Discussing on the implementation of the 7<sup>th</sup> CPC recommendation, Staff Side Leader Sri Subhasis Banerjee proposed to form a Committee under the supervision of Head of Office. Dr. Bhoop Singh, Director agreed to the proposal and said that consulting with Smt. Anjali Sharma, Head of Office & Sri Sadananda Sardar, DDO one Committee will be constituted with experienced staff of Accounts and Administrative wing. He asked Sri T.K.Banerjee, Steno-II to suggest the names. Few names were suggested by several members who were present in the meeting.

**(3) To discuss about long pending 'Cadre Restructuring' of NATMO**

Sri Subhasis Banerjee enquired about the status of 'Cadre Restructuring' as it is a long pending issue. Director replied that no progress has been found till date and thus he advised Head of Office to give another reminder to DST (SMP).

**(4) To discuss about approval of new Recruitment Rules through DST/ DoPT**

Discussing the issue of Recruitment Rules, Director exclaimed that no satisfactory improvement has been made though he is trying his best since his joining as Director of NATMO.
